

## Terms and Conditions of „*eColorland becomes Colorland*” competition

PLEASE READ THESE TERMS AND CONDITIONS CAREFULLY; YOU AGREE TO BE BOUND BY ALL TERMS AND CONDITIONS CONTAINED OR REFERENCED IN THESE TERMS AND CONDITIONS. IF YOU DO NOT AGREE UPON THESE TERMS AND CONDITIONS, YOU MAY NOT TAKE PART IN THE CONTEST ORGANIZED BY CYFROWA FOTO COMPANY.

### 1. General Provisions:

a) The „*eColorland becomes Colorland*” contest is organised by Cyfrowa Foto company (“Promoter”) with its registered office at Zaczernie 190, 36-062 Zaczernie, Poland, email address: [info.uk@colorland.com](mailto:info.uk@colorland.com). The Promoter is the owner of [www.colorland.com](http://www.colorland.com).

b) The contest is open to users aged eighteen (18) years or older. Every person who takes part in the contest („Competitor”), must have a registered account on Facebook with his/her real personal data. Participation in the contest is free and voluntary.

c) The contest is open for all users who fulfil the requirements described in point „3b”, except employees, agents, contractors or consultants of the Promoter and their immediate families, the Promoter’s associated companies and anyone else personally connected with the Contest.

d) The contest is open for entries on 10th July 2017, 1 p.m. CET („Opening date”) and closes on 17th July 2017, 11 p.m. CET („Closing date”). The winners of the contest will be announced by 24th July 2017 and presented on a landing page created for this purpose: [http://gr.ecolorland.co.uk/rebrand\\_results](http://gr.ecolorland.co.uk/rebrand_results)

e) The contest is not sponsored, promoted or administrated by Facebook. Information delivered by the Competitor may be used for the purpose of properly conducting the contest and to deliver the eventual prize.

### 2. Terms and course of the competition

a) Taking part in the competition should be done by filling in the form presented on the landing page: [http://gr.ecolorland.co.uk/rebrand\\_contest](http://gr.ecolorland.co.uk/rebrand_contest). All entries shall be accepted in the specified period of time: from 10th July 2017, 1 p.m. CET („Opening date”) to 17th July 2017, 11 p.m. CET.

b) How to participate: To participate in the *eColorland becomes Colorland*” you should properly fill in the application form by entering the real data and answering the question: Which product from new colorland’s offer would you like to receive and why?”. An user is considered as participant once he/she properly filled the form and expressed the acceptance of „Terms and Conditions” by clicking the „Participate” button. Application form will be established once the Promoter received and accepted it.

c) Evaluation of all applications shall be done by a Jury, specified and create by the Promoter. Decisions provided by the Jury are final and cannot be denied. The Jury will evaluate participants
